

Governance Holland High Tech

Holland High Tech is an independent foundation (Stichting TKI HTSM) funded by the Ministry of Economic Affairs. Its organisational structure comprises a Board (Bestuur), a Supervisory Council (Raad van Toezicht), a Programme Council (Programmaraad), an Executive Director (Algemeen Directeur) and an operational Office (Bureau). The Board is responsible for the foundation's overall strategy and its implementation. The Programme Council advises the Board on R&D programming for the High Tech Systems and Materials sector, while the Supervisory Council provides the Board with strategic advice. The Executive Director and the Office are responsible for the day-to-day management and operations.
